CANCELLATION CONDITIONS (applicable to Sponsorship, Advertising, and Exhibition)

NOTE: This booth reservation form is a contractual agreement. Signature indicates a binding contract subject to cancellation terms noted below:

- 25% of the agreed amount due if the cancellation is made before 15th November 2014
- $\bullet 50\% \ of the \ agreed \ amount \ due \ if the \ cancellation \ is \ made \ between \ 15^{th} \ November \ 2014 \ and \ 1^{st} \ February \ 2015 \ and \ 2^{st} \ And \ 2^{st$
